## PROGRAMS

### ANIMAL RESCUE CENTER

Nassau Humane Society provides care, shelter and support for homeless animals at the Animal Rescue Center. We fund medical and surgical care for sick and injured animals brought into the Animal Rescue Center, and support spay and neuter programs. We provide adoption, foster and other services to help homeless animals from our area find permanent homes. We also provide community outreach and education about pet ownership, and maintain a community pet food bank for low income families.

### DOG PARK

Members of the dog park may bring their dogs to enjoy a large dog play area with a bone shaped swimming pool, four bathing stations, a separate small dog area with a waterfall pool, and a training area. All proceeds benefit the Animal Rescue Center.

## GIFTS THROUGH WILL OR TRUST

When you make a bequest to The Nassau Humane Society, you will ensure that some or all of your assets will be used to help save the lives of dogs and cats. There are several types of bequests:

- **SPECIFIC BEQUEST** – a specified amount, or specific asset, designated in your will or trust as a gift to NHS
- **RESIDUARY BEQUEST** – designates that a specific percentage of your estate, or all, will be paid to NHS after payment of all other distributions, including debts, taxes, expenses and other bequests have been made.
- **CONTINGENT BEQUEST** – specifies that your estate, or a portion of it, will go to NHS if your other named beneficiary(ies) predeceases you.

To make certain that your charitable intentions are carried out, all wills, living trusts and their codicils or amendments should be prepared by or with the advice of your attorney. You can share with your attorney the following language that can be included in your will or living trust and tailored to address your specific wishes:

*I give to NASSAU HUMANE SOCIETY, Inc., Federal I.D. No. 59-2667141, 639 Airport Road, Fernandina Beach, FL 32064, (the sum of \$ \_\_\_\_\_) (all or \_\_\_% of the residue of my estate), to be used for its general purposes.*

## GIFTS OF RETIREMENT PLANS

A gift to Nassau Humane Society through a retirement plan (IRA, 401(k), 403(b), Keogh or other qualified retirement plan) is one of the easiest and most tax effective ways to ensure a strong future for NHS and the thousands of animals we help each year. Such assets, if given to an individual, would be subject to various kinds of taxes, but if given to a charity such as NHS, they would not be taxed.

## GIFTS THROUGH LIFE INSURANCE PLANS

You can use your life insurance plan to fulfill your goals and meet the needs of the dogs and cats helped by NHS.

You can also donate your policy to NHS and get a charitable deduction during the year of the gift.

## TRANSFER BANK OR BROKERAGE ACCOUNT

An easy way to make a gift to Nassau Humane Society is to name us as the beneficiary of your bank or brokerage account. You retain full control of the account during your lifetime, and on your death, any assets remaining would be transferred to NHS.
